INTRODUCTION

This document is the Index to the Administrative Record developed for Sites 5 and 8 at the Naval Construction Battalion Center (NCBC), Davisville, pursuant to requirements in the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA), as amended by the Superfund Amendments and Reauthorization Act (SARA).

On 21 November 1989, NCBC was placed on the U.S. Environmental Protection Agency's (EPA) National Priorities List (NPL), a compilation of national priority sites among the known sites with releases or threatened releases of hazardous substances, pollutants, or contaminants. A Federal Facilities Agreement for NCBC-Davisville was signed on 23 March 1992.

The materials contained herein were considered or relied upon in selecting the appropriate response actions for these two sites. The documents listed in the index are either site- specific documents/correspondence or are guidance documents used in selection of the response action. All other guidance documents are incorporated by reference and are available for review as part of EPA's Compendium of Guidance Documents maintained by EPA Region I at its Boston office.

The Administrative Record is set up in sections that follow the stages of the Navy's Installation Restoration (IR) Program and the Administrative Record Index. Each section has the documents and correspondence pertaining to that phase of the IR Program.

The Administrative Record Index on this CD differs from the ARI officially approved in September 1995 (Appendix D in Document 5105), because, since that date, relevant documents have been found that were not included in the original Administrative Record. These documents have been numbered and added to the AdministrativeRecord.

In addition to this Administrative Record, an Information Repository is maintained at the North Kingstown Free Public Library at North Kingstown, Rhode Island.
